- 4. Convene clan meetings when and where possible.
- 5. Convene a second Carr/Kerr Clan Derbhfine within five years. (2)
- 6. Notify appropriate authorities in Scotland that a North American Clan Carr/Kerr is now being formed.
- 7. Perform such other Clan activities as required.

Robert S. Miller, husband of Margaret Carr (DAR number 436478, James Karr of New York), is also the Carr/Kerr and Karr family genealogist for North America, and has traced his wife's Scottish (Carr, Karr and Kerr) lineage in America into the late 1600's: with direct descendants who served in the Revolution of 1776, the War of 1812, the Civil War, the War with Spain, Mexican American War, WW-I and WW-II.

There being no further business before the above convened Derbhfine, it was concluded at 1130

(1) A Derbhfine is convened where the appointment of a clan Commander is sought.

(2) Clan recognition for new clan by the Court of the Lord Lyon in Scotland is initially undertaken through a Derbhfine: in which a Clan Commander is appointed, who is then required to prepare the ground-work for the establishment of a new clan, which within 5-10 years approaches the Lord Lyon in Scotland for formal recognition.

A Derbhfine was convened at the Carr Clan Tent at the Scottish Highland Games in Winter Springs on Saturday, January 15, 2011. For the past half-decade Margaret Gannon (Carr) Miller, her husband, Robert, their three sons, Robert, Bradley and Brent, in conjunction with other Carr family members in Florida and elsewhere in the United States, have actively participated in attendance at Scottish games in Florida: to gather interest for the formation of a Carr Clan organization for North America.

In the last three years of Scottish Games in Florida some fifty Carr members (and Sept names as well) have been recruited. This informal membership have several Carr Clan newsletters annually at no expense to the members.
